- A.** Conduct a public hearing on the proposed tax rate of \$0.8417/\$100 valuation from properties on the tax roll in the preceding tax year for the City of Rockdale. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 7.99% AND THE AVERAGE VALUE HOMESTEAD WILL PAY \$31.17 MORE IN PROPERTY TAXES THAN LAST YEAR.
