(a) Each candidate for City Council must meet the eligibility requirements set forth in State law and complete an application for office as required by State law. A copy of the application may be obtained from the City Secretary's office or rockdaletx.gov	2024 General Election February 16, 2024 by 5:00 PM for May 4, 2024 General Election			
(b) A qualified candidate must be 18 years of age; must be a registered Voter in territory; Must be a city resident for one (1) year prior to the filing deadline.
