## CANDIDATE ELIGIBILITY REQUIREMENTS & DEADLINE TO FILE

CANDIDATE ELIGIBILITY REQUIREMENTS	DEADLINE TO FILE CANDIDATE APPLICATION**
<p>(a) Each candidate for City Council must meet the eligibility requirements set forth in State law and complete an application for office as required by State law. A copy of the application may be obtained from the City Secretary's office or <a href="http://rockdaletx.gov">rockdaletx.gov</a></p> <p>(b) A qualified citizen who desires to become a candidate for City office must, in addition to the qualifications set forth in subsection (a) above, file with the City Secretary a petition signed by at least 25 qualified voters of the appropriate district in the case of a single member district Councilmember candidate or of the City in the case of a candidate for Mayor, recommending candidacy <i>or</i> pay a filing fee of \$100.00. The petition or filing fee must be filed with the City Secretary at the time of filing for candidacy. Each signer of a petition for candidacy must indicate his voter registration number or date of birth, date of signing and place of residence on the petition. Within five days after the petition is filed, the City Secretary must notify the candidate whether the petition satisfies the requirements prescribed by this Charter. If the petition is found insufficient, the City Secretary will return it immediately to the person who filed it with a statement certifying its insufficiency. Within the regular filing period, a corrected petition may be filed for the same candidate.</p>	<p><b>FILING PERIOD: Wednesday, January 15, 2025 to Friday, February 14, 2025 at 5:00 p.m.</b></p> <p><b>PERÍODO DE PRESENTACIÓN: del miércoles 15 de enero de 2025 al viernes 14 de febrero de 2025 a las 5:00 p.m.</b></p>
